Continuing Education - Ethics Course Requirement

South Carolina Code Ann. Section 38-43-106 outlines the overall requirements for producer compliance with continuing education in the state of South Carolina. Specifically, South Carolina Code Ann. Regulation §69-50 II. C. provides that the Director of Insurance may use his discretion to mandate certain continuing education courses to be taken by producers to meet continuing education compliance. To make certain that ethical standards are being consistently practiced in the marketplace, and to ensure that the South Carolina Department of Insurance is uniform with other states in its administration of producer licensing standards adopted by the National Association of Insurance Commissioners, the Department will require that ethics training be included as part of the biennial Continuing Educational requirements.

The purpose of this Bulletin is to notify all resident South Carolina insurance producers who must comply with continuing education requirements of their responsibility to complete three hours of ethics course training by May 1, 2008, and each biennial Producers who fail to meet this requirement for any compliance period thereafter. compliance period may have their license canceled. An approved ethics course taken prior to May 2, 2006 is not eligible for ethics course credit.

Frequently Asked Questions and Answers Continuing Education Ethics Course

- Q. When will the new ethics course requirement take effect?
- A. By the May 1, 2008 biennial producer continuing education (CE) compliance period, all resident producers who must comply with CE requirement must have completed a three hour ethics course.
- Q. Is this three hour course requirement considered a part of the 24 hours of CE credit?
- A. Yes.
- Q. What if I took an ethics course three and one half years ago, will that count?
- A. Any course taken prior to May 2, 2006 is not eligible. The three hour course must have been completed between May 2, 2006, and May 1, 2008.
- Q. Are exempt producers required to complete an ethics course?
- A. If a producer who is exempt from CE is actively selling, negotiating, or soliciting insurance products, they are encouraged to complete a three hour ethics course biennially.
- Q. What happens if a producer fails to comply with an ethics course requirement?
- A. That producer may have his/her license canceled. In order to regain licensing privileges, the producer must take and pass the producer licensing examination.
- Q. If a producer completed a six hour course that contained three hours of ethics training, how can the producer provide proof the course contained three hours of ethics?
- A. The producer should contact the course sponsor and ask the sponsor to provide a copy of the course outline and a list of everyone who completed the course to the Department. If the Department finds that the course has at least three hours of ethics education, the information will be forwarded to Prometric, CE Administrator, so the producer can receive credit for taking the ethics course.
